### INSTALLATION AND OPERATING INSTRUCTIONS

#### Safety and Electrical Parameters Continued

This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) this device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

- These LED tubes are intended for lighting systems only.
- These LED tubes are for indoor use only. Maximum ambient temperature must not exceed 45°C (113°F).
- Avoid use in sunlight, abnormal heat, or moist / condensing environments.
  - Working temperature : -20°C~45°C (-4°F~113°F)
  - Working humidity : 30%~85%
  - Storage temperature : -40°C~65°C (-40°F~149°F)
  - Storage humidity : 10%~90%

- These LED tubes are not intended to be repaired by the user, manufacturer, or service personnel in any case of failure.
- These LED tubes are constructed such that they do not rely upon the luminaire enclosure for protection against accidental contact with live parts.
- These LED tubes are intended to be used in dry or damp locations only.
- These tubes are intended to be installed in the same orientation as the fluorescent tubes they are replacing.
- Suitable for use with the following emergency equipment: Keystone Technologies, model: KT-EMRG-LED-5-500-AC.

- Only use the control provided with or specified by these instructions to control this lamp. This lamp will not operate properly when connected to a standard (incandescent) dimmer or dimming control. Only operate with specific dimmer KTD-TLED-FF1-VDIM manufactured by Keystone Technologies.

**CAUTION:** LEDs are extremely bright. Do not look directly at the LED light source for extended time as over-exposure may cause harm to the eyes.

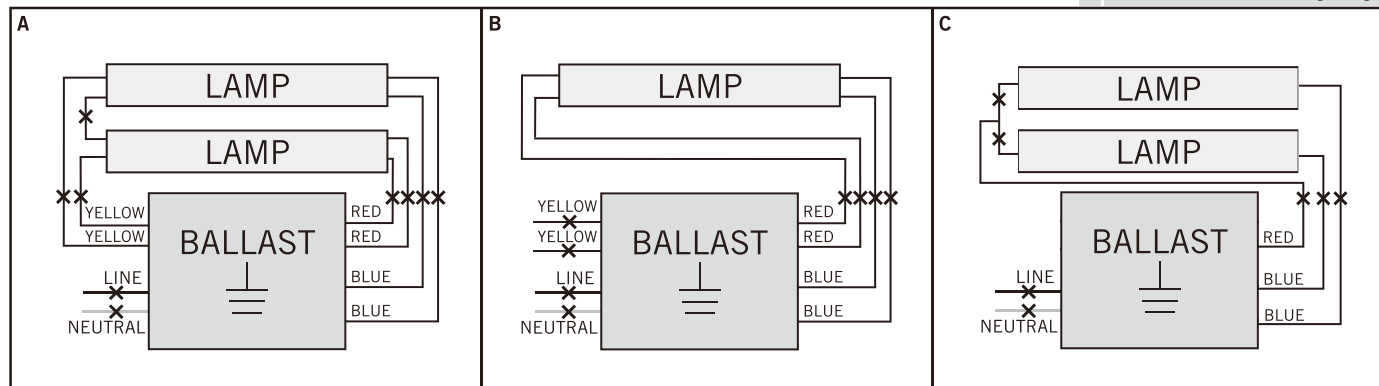
**CAUTION:** Not rated for use in Vapor Tight style fixtures. Do not install in vapor tight style fixtures. Doing so will void the warranty.

#### Instructions for Single-Ended Wiring Installation

##### Removing Existing Fluorescent System

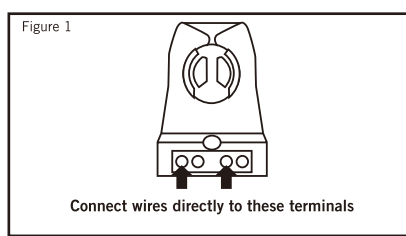
- Disconnect power from fixture.
- Remove fluorescent lamp(s).
- Remove lens and wiring compartment, if applicable.
- Cut all wires connected to the ballast as shown below and remove ballast.
- Identify what type of lampholders are in fixture. Single-Ended wiring installations of Keystone Direct Drive X2 tubes require non-shunted G13 lampholders.
- If applicable, replace lampholders with non-shunted lampholders.

##### Typical Ballast Configurations

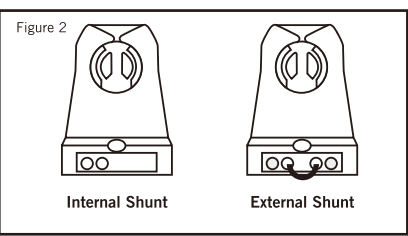


**CAUTION: Use only non-shunted lampholders for Single-Ended wiring installations.** Do not perform Single-Ended wiring installation of product in a fixture with shunted lampholders (found in all fixtures using instant start ballasts). If the existing lampholders are shunted, and Single-Ended wiring is desired, remove and replace them with non-shunted lampholders (or remove the external shunt if applicable). Make new connections directly to lampholder terminals as shown in Figure 1 below.

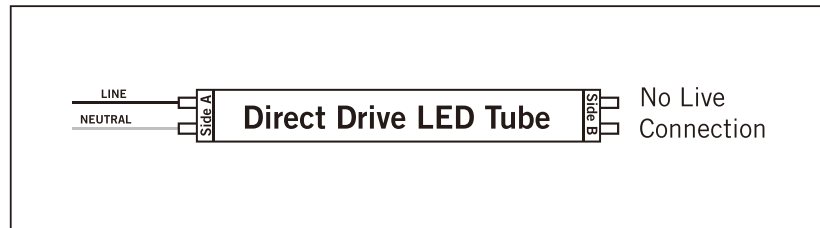
#### Installing the Lamps

**NOTE: For Single-Ended wiring installations, power is only applied to endcap labeled Side A. DO NOT apply power to Side B.**

- Confirm that power is still disconnected from fixture.
- Make sure fixture is properly grounded.
- Follow step 1 for single lamp application or steps 2 & 3 for multiple lamp application, based on the number of lamps in the fixture:

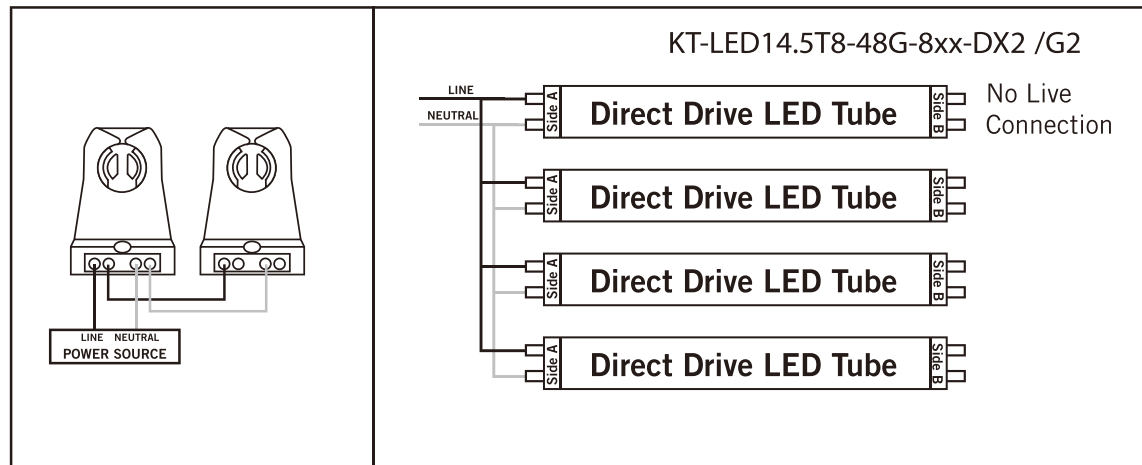
##### Single Lamp

- On the Side A lampholder, connect line (L) and neutral (N) AC wires to the corresponding pins marked (L) and (N) on the endcap. If only one lamp is being installed, proceed to step 4.



##### Multiple Lamps

- Follow the steps above for single lamp connection to connect the first lamp.
- Connect the terminals on the powered lampholder on the first lamp to the matching terminals on the powered lampholder on the second lamp with line and neutral wires as shown below. Continue daisy-chain connection for each additional lamp.



- Complete all electrical connections with appropriate connectors/wire nuts as needed, per all local and national electrical codes.

**NOTE: There should not be any exposed wires from sockets left unconnected.**

- Replace wiring compartment cover.
- Install all of the Keystone Direct Drive X2 tubes, making sure Side A is installed in the lampholders wired to the line and neutral.
- Install LED tubes so that the LEDs are pointed in the proper direction for illumination, and install any lens or diffuser as applicable.
- Apply power to fixture and check for illumination.

#### Instructions for Double-Ended Wiring Installation

##### Removing Existing Fluorescent System

- Disconnect power from fixture.
- Remove fluorescent lamp(s).
- Remove lens and wiring compartment, if applicable.
- Cut all wires connected to the ballast as shown in Diagrams A, B, and C on Page 1.
- Identify what type of lampholders are in fixture. Double-Ended wiring installations of Keystone Direct Drive X2 tubes can be used with shunted G13 or nonshunted G13 lampholders (with instructions to externally shunt). See Figures 1 and 2 on Page 1.

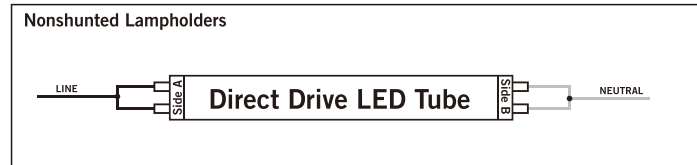
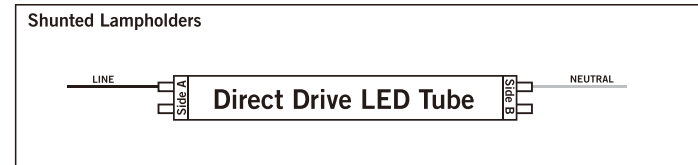

#### Installing the Lamps

- Confirm that power is still disconnected from fixture.
- Make sure fixture is properly grounded.
- Follow step 1 for single lamp application or steps 2 & 3 for multiple lamp application, based on the number of lamps in the fixture:

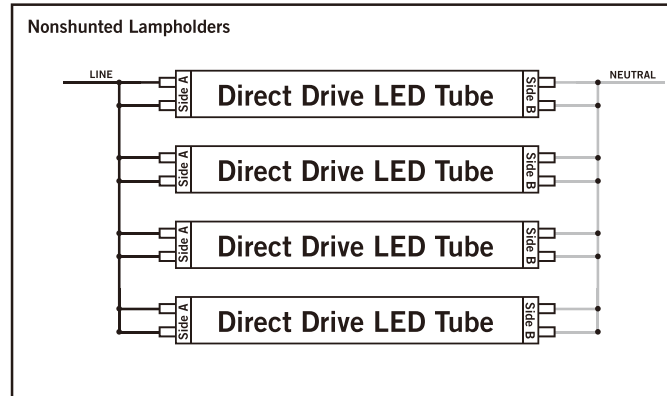
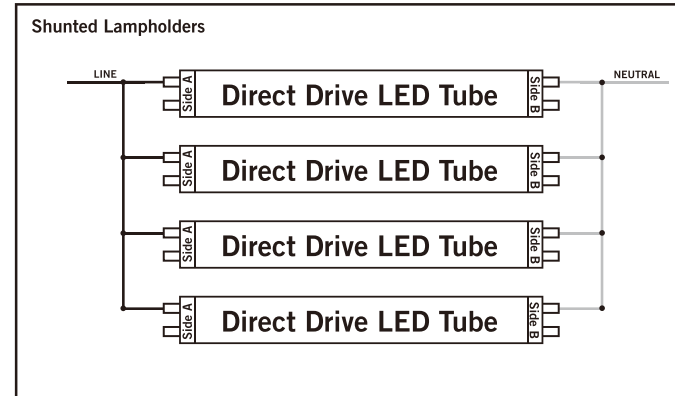
##### Single Lamp

- From AC wires, connect line (L) to Side A lampholder and neutral (N) to Side B lampholder. If only one lamp is being installed, proceed to step 4.



##### Multiple Lamps

- Follow the steps above for single lamp connection to connect the first lamp.
- Connect the terminals from the first lamp to the matching terminals on the lampholder of the second lamp with line and neutral wires as shown below. Continue daisy-chain connection for each additional lamp.



- Complete all electrical connections with appropriate connectors/wire nuts as needed, per all local and national electrical codes.

**NOTE: There should not be any exposed wires from sockets left unconnected.**

- Replace wiring compartment cover.
- Install all of the Keystone Direct Drive X2 tubes. Install LED tubes so that the LEDs are pointed in the proper direction for illumination, and install any lens or diffuser as applicable.
- Apply power to fixture and check for illumination.

#### Safety and Electrical Parameters

These LED tubes are intended to retrofit a UL Listed, surface mount, type IC or non-IC, recessed mount fluorescent luminaire that uses a maximum of 4 straight tubular lamps with or without diffuser. The minimum dimensions of the luminaire are tabulated below:
